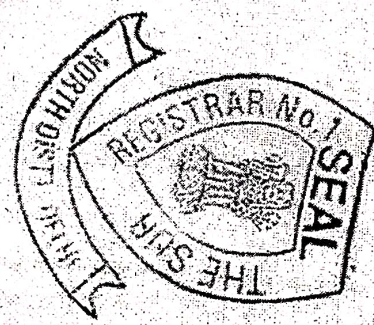

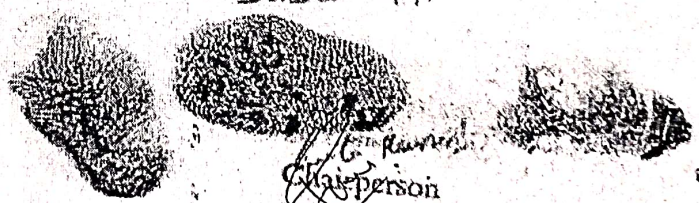

6. THE AIMS AND OBJECTIVES FOR WHICH THE TRUST IS ESTABLISHED ARE:

- i. The trust is being organized for the purpose of relieving the poverty, misfortune, destitution, disadvantage, distress, dispassion and suffering of Indian citizens by promotion of spiritual, physical, mental, educational development and upliftment of adults and children of all without any distinction in caste, creed, sex or religion and to empower the physically challenged and down-trodden.
- ii. To establish, develop, maintain and grant aid in cash or in kind to hospitals, medical schools, medical colleges, nursing institutions, dispensaries, maternity homes, child welfare centers and /or such other similar charitable institutions in India for the benefit and use of the general public.
- iii. To establish, run support and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, research and other institutions of the like nature in India, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.
- iv. To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without any distinction as to caste colour, race, creed or sex.
- v. To create unifying educational, artistic and cultural events and activities, that promote the trust's objects and general funds for the purposes related to the Trust's object.
- vi. To establish, maintain or grant aid for the establishment and / or maintenance of parks, gardens gymnasiums, sports clubs, dharamshalas and rest houses, for use by public in general.
- vii. To promote spiritual studies and open spiritual training and Yoga centers for general public and to increase the natural spiritual fellowship among all persons and to take affiliation from international organizations and to organize spirituals programmes and functions for general participations.
- viii. To establish run, maintain and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help and to provide facilities including procurement and / or manufacturing of artificial limbs (Prosthetics) and Orthotic appliances, including fitting and training in use of prosthetics.
- ix. To grant relief and assistance to the needy victims during natural calamities such as famine, earth quake, flood, fire, pestilence, etc; and to give donations and other assistance to institutions, establishments or persons engaged in such relief work.

- x. To establish permanent exhibits and live displays and community based educational facilities for courses, workshops, conference, seminar, training programme and educational tours.
- xi. To implements projects on environment conservation, social foresting and to carry out awareness compares regarding degrading environment, pollution research, education and communication programme.
- xii. To initiate socio-legal development and to promote small economic activity development, health and nutrition, urban development, SCs and Tribal Empowerment, agricultural and natural resources, girls education, emergency response, large scale and rural savings and credit projects, encourages access to financial services, through self-managed and controlled self help groups.
- xiii. Dealing with population explosion through medical services media in rural, urban, tribal zones as well as hutment areas of Indian City, provides free medical facilities in conducting camps for immunization, Aids control/ awakening programmes, supports education-cum-motivational efforts with quality family planning and mother and child Health services, AIDS care services and general include prevention education, access to prevention technology, voluntary testing and counseling and care for persons with HIV/AIDS
- xiv. To start creche facilities in shum-areas, mid-day meal, regular medical check-ups and a non-formal education, specialist training for Aanganwadi, workers to help mothers and children in the community, home for abandoned children that locates adoptive families, finds placements and helps returns children to their families.

To generate and increase employment potential by locating indigenous recourse and developing methods like Self-help groups and to assess and generate awareness and provide services relating to issues such as electronics, health, education, sanitation, communication, housing income and co-operative schemes.

7. That the Trust funds may be augmented by the income from the initial funds and also by donations and other contributions from time to time.
1. It is hereby declared that no part of this Trust Property or its income shall be applied for any purpose other than for the objectives of the trust being in force and the surplus funds in any of the trust shall be invested as per provision of Income Tax act 1961, and to get Registration for Tax exemption 80G, 12A and 35AC. For Foreign Contribution of Regulation Act, 1976, the trust has to FCRA Registration from Ministry of Home Affairs, Govt. of India.
2. TO OPEN SAVINGS BANK ACCOUNTS/CURRENT BANK ACCOUNTS WITH ANY NATIONALISED BANKS/POST OFFICE /PRIVATE FIRMS'S / PRIVATE BANK I.E. IDBI, ICICI, CITY BANK AND OTHERS GIVE DIRECTIONS TO THEM AND TO TRANSFER ENDORSE OF AND SIGN GOVERNMENT SECURITIES PROMISE OR NOTICE, SHARES, DEBENTURE, SECURITIES, INSTRUMENTS ETC. AND ALL THESE ACCOUNTS WILL BE JOINTLY OPERATED BY THE SETTLOR AND TRUSTEE TRUSTEES WILL DECIDE TO PASSED A RESOLUTION THAT CONCERNED PARTICULAR NAME HAS POWER TO SIGN ON CHEQUE FOR TRANSACTIONS OF MONEY. THE SETTLOR SHALL NOT BE WITHDRAWN EXCEPT THROUGH A CHEQUE SIGNED BY TUSTEE. DULY AUTHORISED BY THE TRUSTEES FROM TIME TO TIME. EVERY FIVE YEAR THE JOINT SIGNATOY TRUSTEES NAME IN THE BANK'S ACCOUNT WILL BE REPLACED BY ROTATION.
3. That the trust fund shall not be applied for any purpose other than those specified in para 3 hereinabove.
4. That the Trustees shall always maintain proper accounts of the Trust which shall be kept at the office of the trust.
5. That for the furtherance of the objects of the trust, the trustees shall have the following powers:
 - a. To accept any donation, contribution, grant or subscription in cash or in kind, from any person(s), body of persons or trust, with or without conditions.
 - b. To apply the whole or any part of the income of the trust, or the trust funds or accumulations thereto, to anyone or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
 - c. To convert ad deal with the trust property and /or and investments for the time being.

- e. To borrow or raise or secure payments of moneys and also to lend money either with or without security.
 - f. To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Funds.
 - g. To let out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.
 - h. To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Funds.
 - i. To appoint constituted attorneys or agents and to delegate to such attorneys or agents all any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others on his or their place.
 - j. To appoint or make provision for the appointment of any person (including all or any of the Trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such manner and such to such rules and regulations as the Trustees may prescribe and also to appoint or provide for the appointment of separate Trustees to hold any fund or investment subject to the provisions of this Deed in such manner and subject to such rules and regulation as the Trustees may from time to time think fit.
 - k. To make, vary, after or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and / or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
 - l. To start, abolish, discontinue and restart any charity or charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.
 - m. To set apart and / or allocate the whole or a part of the income or the corpus of the Trust Funds or part thereof for any of the objects of the Trust.
 - n. To give aid by way of donations out of the income or the corpus of the Trust Funds or otherwise, to different charitable institutions, societies, organizations or Trusts in India which may have been established or which may hereafter be established for the like charitable purposes mentioned on these presents or any of them to enable such institution, societies, organization or Trustees to start maintain, or carry out such charitable objects.

- p. To establish religious worship places, spiritual retreat and meditation centers & seminaries.
- q. To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- r. To borrow money either on the security of any property comprised in the Trust Funds or otherwise for all or any of the purpose of these presents, and it shall be lawful for the Trustees to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.
- s. To apply to the government, International Funding Agencies, public bodies, urban, local, municipal district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the government departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.
- t. To take over or amalgamate with any other charitable trust, society association, or institution with similar objects.
- u. To establish, promote, manage, organize or maintain or to assist in establishing promoting, managing, organizing, or maintaining any branch of the Trust or any other Trust or its branch with object similar to those of this Trust and to promote or carry on the affiliation or amalgamation of such other Trust this Trust.
- v. To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
- w. To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.
- x. To transfer all or any part of the property, assets, liabilities and engagements of the Trust to any one or more of the trust, societies, institutions or associations with which this Trust is authorized to amalgamate.
- y. To transfer and handover the trust to any other Society, Corporation, Institution, Trust or Organization on such terms and conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the Society, Corporation, Institutions, Trust or Organization with the powers, provisions, agreements and declarations, appearing and contained in these present subject to such modification as may be necessary and consequent to such transfer of the Trust Fund. The trustees for the time being of these present shall become discharged from the trust hereof relating to trust funds so transferred.

2. The trustees shall be accountable only for such moneys, stocks, shares and funds as shall actually come into their hands and trustee shall not be answerable or

- accountable for neglected, default, acts or omission or commission of the other Trustees, not or any banker or other person with whom the trust properties or any securities may have been deposited or kept.
3. The Trustees will not be entitled to receive any remuneration, but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
 4. The number of the Trustees shall fall not be less than three and more than nine. If the number of the Trustees shall fall below three, the trustees shall not, except for the purposes of filling any vacancy, act so long number is below the said minimum.
 5. The managing Trustees for the time being will be at liberty to appoint additional trustee within the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustees for the time being consider proper. A person shall cease to be a trustee either (I) if he without leave of absence does not attend three consecutive meetings of the trustees or for one calendar year, whichever is longer, or (II) if he is requested to resign by 3/4th or as near thereto as possible of the remaining trustees.
 6. The trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations:
 - a) Two Trustees shall form a quorum for a meeting of the trustees.
 - b) All matters will decided mutually by Trustees.
 - c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidencing writing under the hands of two thirds of the trustees shall be as valid and effectual as Resolution duly passed at a meeting of trustees.
 7. The trustees shall have the power to determine in case of doubt whether any moneys or property shall or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.
 8. The accounting year of the Trust shall be financial year ending on 31st March every year.
 9. The trust and the trust funds shall be and irrevocable for all times.
 10. The office of the trust shall be situated at Delhi unless changed by the trustees by two third majority.
 11. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions hereof shall be constructed accordingly.

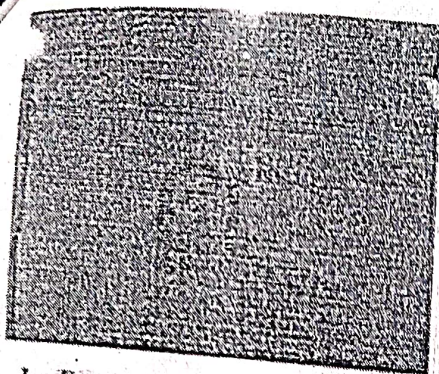

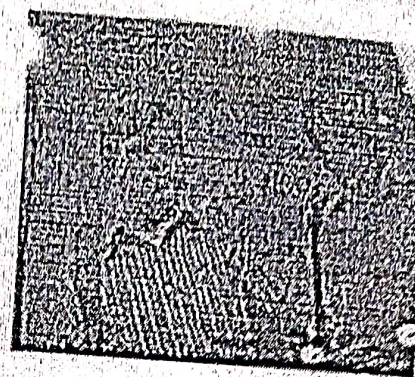
